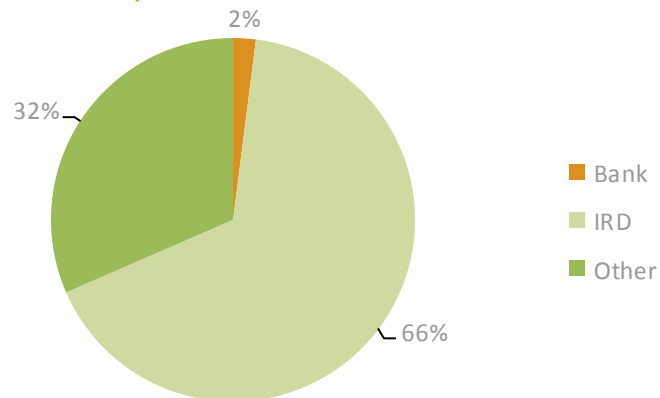

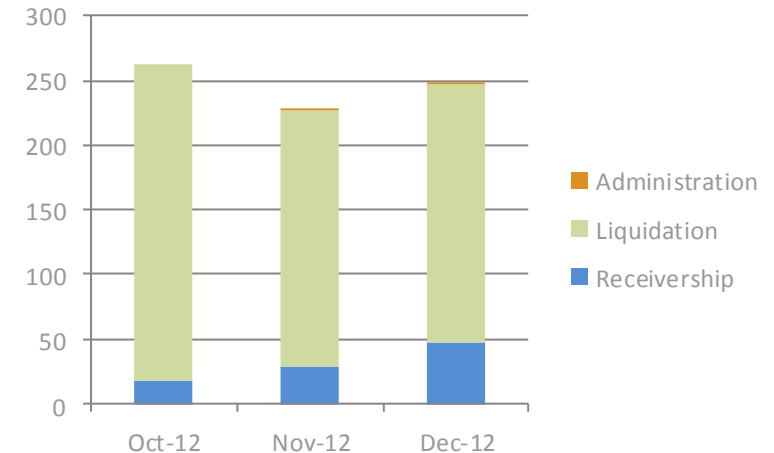
What the quarterly figures are showing

- A small increase in receivership appointments during December while liquidation appointments were consistent with November. 48 receivership appointments and 199 liquidations were recorded in December.
- Total insolvency appointments in the three months to December were 740. Liquidations accounted for 641 of those appointments.
- Total number of applications made to the High Court to liquidate companies were 323 for the three months to December.

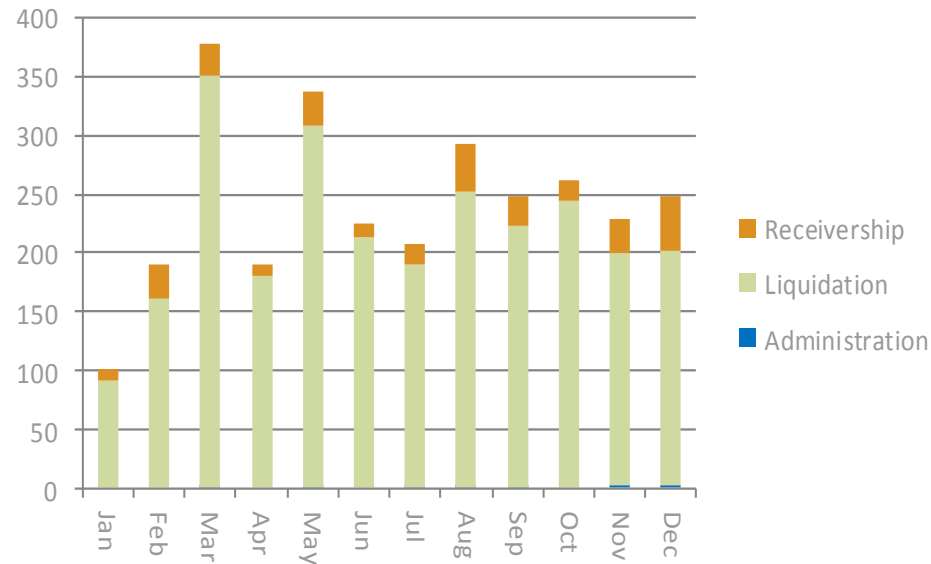

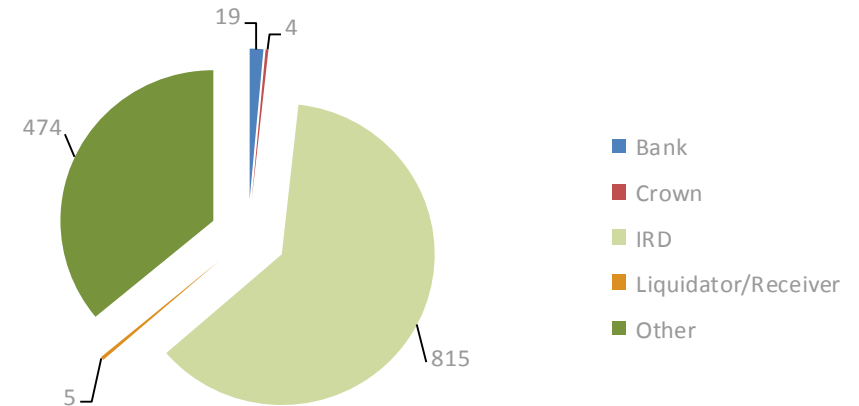
What the annual figures are showing

- Total insolvency appointments during the year were 2912. The total applications made to the High Court to liquidate sit at 1317 (not shown in the graph above).
- Liquidations accounted for 2610 of those appointments with Administrations only accounting for 9 appointments.
- Unlike the situation in Australia, administrations are clearly not in favour. Most administrations ending in liquidation or receivership.
